- Perform business impact analyses and assess risk tolerance levels.
- Ensure organizational compliance with ISO 27001:2022 information security standards.
- Guide compliance efforts for NIST frameworks (CSF, AI RMF, 800-53).
- Lead compliance initiatives for NIS2 Directive and DORA requirements.
- Monitor regulatory landscape and advise on emerging compliance obligations.
- Prepare for and support in external and internal audits and Penetration and Resilience Tests.
- Translate regulatory requirements into actionable technical controls.
- Review development practices and recommend security improvements as required.
- Respond to assessment requests from customers.
- Create and maintain compliance documentation and evidence.
- Participate in security architecture and design reviews.
- Support implementation of security controls based on risk priorities.
- Develop risk-based security roadmaps aligned with business objectives.
